Stain Resistance: With proper care, materials treated with **Resilience^{SR}** can be easily cleaned and will guard against stains maintaining the desired surface appearance for years to come.

Anti-Microbial & Anti-Bacterial Protection: Products treated with **Resilience^{SR}** are engineered to inhibit bacterial growth, as well as fungus, mold and mildew spores, resulting in a more hygienic environment.

Abrasion Resistance: **Resilience^{SR}** provides additional wear properties and surface durability to any vinyl or faux leather, thereby increasing the life of the material. **Resilience^{SR}** is not visible, and does not affect the hand of the material. **Resilience^{SR}** is engineered to last, even after repeated cleaning and wear. Specify **Resilience^{SR}** for the most demanding healthcare and hospitality applications.

CARE AND CLEANING INFORMATION

WS: Water/Solvent Cleaner – Spot clean, with a mild solvent, an upholstery shampoo, or the foam from a mild detergent. When using a solvent or dry cleaning product, follow instructions carefully and clean only in a well-ventilated room. Avoid any product that contains carbon tetrachloride or other toxic materials. With either method, pretest a small area before proceeding. Prompt cleaning is always recommended.

RESILIENCE^{SR} CARE AND CLEANING INFORMATION

Step 1: Mild soap and water, then rinse with fresh water and wipe with a clean cloth.

Step 2: Wipe affected area with a soft cloth or soft bristle brush using a non-abrasive cleaner, i.e. Formula 409 or Fantastik. Rinse with fresh water and wipe dry.

Step 3: 10% solution of household bleach and water. Rinse with fresh water and wipe dry.

Step 4: 25% solution of alcohol and water. Rinse with fresh water and wipe dry.

Step 5: 25% solution of lighter fluid or nail polish remover and water. Rinse with fresh water and wipe dry.

Regular Cleaning and Maintenance: Step 1 (*Dirt, Dust, Grime*)

Oils: Steps 1 & 2 (*Organic & Petroleum based*)

Food: Steps 1 & 2 (*Ketchup, Chocolate, Coffee, Tea, Juice*)

Healthcare: Steps 1, 2 & 3 (*Blood, Urine, Betadine*)

Difficult Stains: Steps 1, 2, 3, 4 & 5 (*Eyeshadow/Mascara, Lipstick, Crayon, Grease, Mustard, Ink/Permanent Markers, Paint*)

NOTE: The use of commercial vinyl conditioners and protectants is **NOT RECOMMENDED**.
